#### **New Properties Finders Fee**

It is the policy of the WEGM to reward its members with a finders fee for locating new properties for the club to lease. The member will be paid \$240 or receive credit for \$240 in membership dues upon the club approving the lease for club use. The member must act as an agent between the landowner and the WEGM. To receive the finders fee, you must register in writing with the club secretary your intent to begin discussing a proposed lease with the landowner. You cannot receive the finders fee unless registration is complete and the lease is approved by the WEGM.

### STANDING RULES

### RULE OF THE MONTH:

CAMP AND MINNING AREAS, SITE REQUIREMENTS:

#5. Abandoned Camp sites- It is the member's responsibility to remove all trash, broken or torn equipment from the camp site upon leaving the camp site. If a camp is not utilized (staying overnight) for a period of six (6) months, the Board of Directors has the authority to remove and dispose of all such equipment left on the property.

#6 River Bank Appearance- All tables, chairs and other camping accessories shall not be left unattended within the required fifty (50') foot undisturbed buffer zone.

A. NO cutting of ANY vegetation within the required (50') foot undisturbed buffer zone along the rivers on club leased property.

**#7.** Camp Appearance- All camp sites shall be kept in a neat and orderly condition at all times. Neat

and orderly meaning all mining equipment, buckets, tools, personal belongings, etc. should be stored in such a manner as not to appear in disarray or neglect to a normal prudent person.
